

You will already be aware the police force watchdog HMICFRS has placed Wiltshire Police into 'special measures' as a result of its performance.

The Inspectorate's report is a sobering read and is highly disappointing, as I know it will to our county's residents. It's especially disheartening because I know Wiltshire Police has many dedicated officers, staff and volunteers, working hard to deliver a quality, efficient, frontline service.

But this report makes it clear - there are areas of concern Wiltshire Police need to address: victims of crime, vulnerable people and our communities deserve better.

You had told me this in volume when I was on your doorstep and the results of my countywide survey and consultation only confirmed this, as well as from local councillors and MPs, on the policing service they were getting.

It was fortunate those areas highlighted by the Inspectorate's report had already been picked up as part of my own strategic assessments of the Force and it meant this shaped my Police and Crime Plan and influenced the robust and challenging scrutiny sessions I hold with the Chief Constable from the outset.

We now have a police and crime plan which ensures Wiltshire Police will meet and deliver those priorities influenced by you, focused on delivering a service the public want and prioritising those crimes that matter most to communities.

My role as PCC is to scrutinise the policing service provided, to challenge where I see performance issues and then support the Chief Constable and Force to implement change and improve in times like these.

The necessary remedial measures needed to make the improvements highlighted in the report are already in progress and my immediate priority is to ensure that Wiltshire's Chief Constable, and his senior leadership team, move with focus and speed, particularly in the Force's response to the public and to vulnerable people and victims, in dramatically improving performance and the quality and effectiveness of investigations.

My aim, alongside the Chief Constable, is for Wiltshire Police to prioritise those crimes which matter most to communities so we can satisfy the Inspectorate but, more importantly, we can satisfy you as residents

Working together, the Chief Constable and I have already agreed on a back-to-basics reset for the Force so I can assure you the process of change is already progressing.

I expect to see a tangible change in service delivery and the Chief Constable has reassured me the necessary changes are in place. I will be receiving regular progress reports from him, and his senior leadership team, to ensure those remedial actions are completed as soon as possible.

Thankfully many residents do not need to use our policing service frequently but when they do, the service they receive should be a quality, frontline, response. I will continue to ask for those assurances on behalf of Wiltshire's residents and ensure Wiltshire Police is delivering on behalf of all of the communities it serves.

DELAYED BIKE RIDES IN FRANCE


At long last and after a two year delay we were able to go on our planned bike trip down the Rhone river valley in May/June. One good thing is that we didn't need to plan all the accommodations etc, having done so two years earlier!

We started in Givors just south of Lyon and over the following nine days made our way approximately 250 miles South alongside the river Rhone to the Mediterranean, with stopovers in Serrieres, Tournon, Le Pouzin, Vivieres, Caderousse, Beaucaire, Saint-Gilles and Port Camargue. As usual for Europe, the cycle path, in this case the Eurovelo Route 17, was excellent, largely traffic free and smoothly paved, allowing us to fully enjoy the scenery, ever changing river views and charming riverside towns and villages.

From the Camargue, we packed the bikes on the car and drove 240 miles to Agen on the Canal du Midi, which joins the Atlantic and the Mediterranean where we spent a few days cycling on the lovely Canal des 2 Mers cycle route, after which we drove another 180 miles to visit friends North of Limoge for 5 days.

We then drove North to Langeais on the river Loire and spent another few days cycling on the Eurovelo 6 cycle route, which connects the Atlantic to the Black Sea – but Carol wanted to come home!! So we went to the ferry at Cherbourg. If anyone is considering similar cycle holidays in Europe we would be pleased to have a chat to share our experiences.

What is a councillor?

Councillors are elected to represent an individual geographical unit on the council, known as a ward or - parish – in Maiden Bradley it is the entire parish. They are generally elected by the public every four years, but there is a Co-option space available on the Parish Council at the moment.

What do councillors do?

Councillors have three main components to their work.

- Decision making Through meetings and attending committees with other elected members, councillors decide which activities to support, where money should be spent, what services should be delivered and what policies should be implemented.
- 2. Monitoring Councillors make sure that their decisions lead to efficient and effective services by keeping an eye on how well things are working.
- Getting involved locally As local representatives, councillors have responsibilities towards their constituents and local organisations. These responsibilities and duties often depend on what the councillor wants to achieve and how much time is available, and may include:
- Going to meetings of local organisations such as the Rural Police Neighbourhood Tasking Group
- · Going to meetings of bodies affecting the wider community (The Warminster Area Board)
- Taking up issues on behalf of members of the public

How much time does it take up?

Quite often councillors say that their duties occupy them for about one hour to four hours a week. Obviously, there are some councillors who spend more time than this - and some less, but in the main, being a parish councillor is an enjoyable way of contributing to your community and helping to make it a better place to live and work. Maiden Bradley Weight Watchers

August update

Following our meeting with our M.P. and Wiltshire Council councillors and officials on May 6th it was agreed that we would all meet again on July 22nd to discuss the Council's findings on HGV movements in our area. The Council said that this would not take long as they now use TomTom and ANPR, (Automatic Number Plate Recognition) to facilitate this.

Unsurprisingly(!) the Council have cancelled the meeting on July 22nd as the data has not been fully developed. This is because they have gone back to a highways consultant, W.S. Atkins, who did the initial survey in 2001 to do this. The three villages involved, Maiden Bradley, Chapmanslade and Corsley all argued that this was unnecessary as a significant cost will be involved and that the traffic situation has got worse over the past 10 years, but to no avail.

So the meeting has now been rearranged for the 2nd September when we will all meet to discuss their findings as to where the HGV's come from and where they are going to as a starting point to trying to stop them, in our case, using the B3092.

Having had that discussion the agreement is that we all meet again on the 2nd December when a final decision will be made on stopping this traffic through our village. This is at the behest of our M.P. Andrew Murrison who is fully supporting what we and the other 2 villages are trying to achieve.

For those of you who are not aware, following the 6th May meeting MBWW have appeared on BBC Radio Wiltshire, BBC Points West, and ITN West Country to further our cause and all 3 programmes have caused a lot of interest from other communities who have similar problems to ours. The three channels of communication have all expressed interest in doing more articles on us if necessary.

Our goal is to get a weight limit imposed on the B3092 and for road freight to use routes designated by Wiltshire Council on roads which are suitable for and maintained at the correct level for heavy goods vehicles to travel along.

QUARRY PLANNING OBJECTION LETTER

MB Weightwatchers submitted an objection to the expansion of Westdown quarry in the Mendips, on the grounds that the planning application does not contain an assessment of the onward HGV impacts on our village. The extra aggregate quarried will be moved all day and night (24 hour activity) from Monday to Saturday and this will increase both the volume and size of Mendip Quarry Producer HGVs using the B3092.

The estimate is that production will rise from 4.85 tons p.a. to 7m tons p.a., an increase of 44%, and undoubtedly we will see an increase in the number of aggregate trucks if planning permission is granted!

The objection letter stated:

I write on behalf of Maiden Bradley Weightwatchers, a civil society group based in Maiden Bradley, Wiltshire, to object to planning applications:

SCC/3795/2021

SCC/3836/2021/IDO

SCC/3837/2021/IDO

SCC/3838/2021/ROMP

The development of Westdown Quarry and the concurrent operation of this and other quarries would have a severe, adverse, and cumulative HGV traffic impacts on the lives of people living in Maiden Bradley and other communities on the B3092.

Our village is already used as a cut-through by HGVs servicing the quarries, even though we live on a B-road that is entirely unsuitable for heavy traffic and is not a designated strategic route. Convoys of HGVs, approximately half of which are HGVs servicing the Mendip Quarry Producers, drive along our narrow main street, where pavements are less than 100cm wide, and they do this at all times of day and night.

The cumulative impact of HGV traffic is destroying the social fabric of our village, causing the following adverse impacts:

- Fear and intimidation, and harm to mental health caused by the size of HGVs, noise, and vibration, including at unsocial hours
- Damage to our physical infrastructure and heritage conservation from vibration and accidents
- Air pollution from dust, and dirt, and emissions
- Damage to our physical infrastructure including bollards, manholes, drains, sewage and water pipes
- Impeding children's safe movement around the village and across the road, when catching the school bus, or in normal play at home
- Pedestrian delay and safety, especially the elderly crossing the road to access the village hall and doctor's surgery

We note with concern that the documents supplied for this planning application do not consider onward and cumulative HGV impacts on communities outside the assessment area.

- The latest clarification provided to the Highways authority (21 October 2021) states that up to 4 million tonnes of material per year will be transported by road (2 million from Whatley and 2 million from Westdown) and that the HGVs from both quarries will use the same routes to deliver material. Much emphasis is made of the fact that "the majority of the transportation effects would have already been considered and accepted as part of the February 1996 permission for Whatley Quarry." (ES, section 12.4) However, onward HGV social and environmental impacts on our village on the B3092 have never been considered.
- The ES and other documents for this application still provide no information about onward routes of HGVs travelling along the A361, even though we raised this issue in our last objection. As no information is provided about onward routes, the potential adverse impact on our village is not included in the assessment area, or in the assessment. Consequently, the report concludes there are no relevant cumulative impacts.
- Although the ES report mentions frequently the use of defined strategic routes in Somerset, no mention is made of any commitment to use defined strategic routes in Wiltshire for onward HGV movements, as no onward routes are included in the assessment.
- The study notes that HGVs will operate at Westdown quarry between 6am and 8pm and at Whatley between 6pm and 4am, Monday to Friday, with a half day operational on Saturday (6am to 12pm). This implies 24-hour HGV movements Monday to Saturday morning and will worsen the HGV impacts our village already suffers from quarry traffic at unsocial hours.
- The study notes that materials will be transported in rigid HGVs (20 tonnes) and articulated HGVs (30 tonnes) and of the total, 65% will be rigid and 35% will be articulated. Yet we regularly see 5 axle (40 tonne) HGVs servicing the Mendip Quarry Producers driving through our village.
- The ES still provides no clarity about how many HGV movements will affect our village on the B3092.
 - Table 12.14 states that on a weekday there will be 1,304 HGV movements per day, with 604 occurring from Westdown between 6.00am to 8.00pm, and 706 occurring from Whatley, between 6.00pm and 4.00am.
 - Table 12.16 confirms that 72% of HGVs will route east on the A361 but does not define their onward journeys.
 - What proportion of these planned HGV movements plan to use the B3092?

For all the above reasons, we strongly object to this planning application and to the use of the B3092 by HGVs servicing the quarries.

LETTER FROM ANDREW MURRISON MP CONCERNING THE DEVELOPMENT OF WESTDOWN QUARRY:

Dear Mr Bond,

I write in strong support of the submission dated 5 July objecting to plans to develop Westdown Quarry submitted by Maiden Bradley Parish Council.

The reason for my objection is the impact of HGVs on villages in Wiltshire whose roads are wholly unsuited and in which numerous old properties face directly onto minor village roads.

Wiltshire Council is in the process of updating its modelling of traffic flows, now ten years old, with a view to remedial action. Until that process is complete, it would not be reasonable to impose further heavy traffic on my constituents.

I hope the applicant will work with the two relevant highways authorities to reduce the impact of its heavy traffic on residents. Until it has done so to their satisfaction, I see no prospect of the very large number of people in Wiltshire and Somerset who have submitted objections being reassured that their lives will not be further disrupted by quarry traffic.

COMMUNITY SPEED WATCH NEWS

Police Community Volunteers working on behalf of the Wiltshire Police and Maiden Bradley



Produced by the Maiden Bradley Community Speed Watch Volunteers to keep the village safe and aware of our activities.

Activity in July has been lighter than normal this Month with 6 sessions logging 441 vehicles counted. However, vehicles booked for speeding over 35mph have risen considerably to 37. The Majority being cars averaging 38 mph.

The HGV traffic continues to remain the same as last month, based on the numbers logged during CSW activity. During an average 60 minute CSW session in July 2022 it showed an HGV every 1.80 minutes, or 683 HGV tonnes per hour through our village.

The HGV configuration remains similar, vehicles are either "32 tonne 4 axle rigid vehicles or 44 tonne 5 / 6 axle Articulated" With a maximum length of 16.5mtrs (54ft - 2ins)

CSW Cannot now operate along the High Street as the change of speed limit notices are up. Now can we operate for 3 months after the signage is out in place. So they will not have gone away. They will be operating in other areas of concern within the village.

We are still waiting for Rngway to forward installation dates for the second SID (Speed Indicator Device) Frome Road.

We are still looking for 2 people willing to help with the putting up and taking down of the SID. Not an arduous task and takes at most 30 minutes once a fortnight to install or take down.
